#### 2.3 Why is this work needed?

The project "IMPEL for sustainability-Heal the world" is to to get insight in the interest of the IMPEL network on Education for sustainability topic.

We believe that this item will have great relevance in the future and that it may therefore give greater relevance if possible and possibly greater visibility to IMPEL's role.

The first step would be to know the interest within the IMPEL community in developing the Education for Sustainability topic. It is intended to test among the IMPEL community about the opportunity to create a specific structure to develop Education for Sustainability.

**We would start** by surveying all the people that make up it, encouraging the national coordinators to extend it to the specific areas of their countries that they work Education for sustainability.

Once the support of the interest in deploying this issue within the network has been achieved, we will begin to work on the implementation in IMPEL's structure and its performance through evolved prototypes.

**In a second phase** aims also to promote the creation inside the network a specific expert team that works in the field of Education for sustainability.



The primary objective, which that team would be to create a network of experts working together on the deployment of education for sustainability reference in Europe for all educative community and citizenship in general, which comes to be called education for lifelong.

Six specific areas within the network would be worked on, namely, early childhood, primary, secondary, high school and professional training, university and non-formal education; the latter aimed at professional groups and citizens in general.

Work among communities and shared experiences working together, promoting and supporting projects in which several countries are involved will be fundamentally promoted. In short, something in which the network has been working since 1992 in other areas, but interconnecting even more if possible the different units that work in the field of education for sustainability in Europe and giving visibility to the different collaborative projects developed in the different aforementioned areas.

The mission of this expert team would be oriented towards one primary focus: "Promote, coordinate and carry out the execution of collaborative actions in the field of education for sustainability, focusing on promoting the creation of a true environmental awareness."

The vision would be oriented towards three primary fields:

- Promote innovative and inclusive methodologies that seek learning for action in the field of education for sustainability in the different areas above mentioned.
- Facilitate collaborative work and intercountry projects in the Network of the different agents working in Europe (focused in principle on countries integrated in the IMPEL network) in Education for Sustainability.
- Achieve complicity among all the people who works in the different countries of IMPEL community in the field of Education for Sustainability, to work together in the transition of our ways of life towards a new culture of sustainability

All this converges in getting to permeate the idea that:

"Give way to an era of open collaboration in which all agents truly add to the path towards truly sustainable development being the driving agent education for sustainability".

These are the six strategic lines to boost the project:

- Boost A2030 under environment perspective
- Promote Innovation, Training, and Knowledge Management in Education for Sustainability
- Expansion and training of sustainable educational centers (formal and non-formal education)
- Connectivity and alignment with other Education formal and non-formal areas with the ultimate goal of truly introducing education for sustainability into the curriculum
- Development of tools for the participation of the Educational Community

So that is why we firmly believe that a fundamental pillar of this structure will be the future center for innovation, training and knowledge management (KIP) in which it has been working within the Capacity Building and Training project.

We are fully convinced that this new area could contribute to increasing the visibility and relevance in Europe that we believe IMPEL deserves due to its trajectory in these almost 30 years of existence, consolidating itself as a European benchmark in the environmental field, which would undoubtedly contribute to the achievement of primary objective, today more than ever necessary, to achieve that intelligent balance between human action and the environment.
